Booking Conditions.

1) All bookings to be accompanied by a deposit of 25% of the total rent. **The balance to be paid two weeks** before the start of the holiday. In the event of cancellation your deposit will be returned less £20 provided that we are able to re-let the property, **otherwise the full rent will be due. You are advised to take out insurance against this event. Discount of £20 per week on two week bookings**
 .If we are prevented by circumstances beyond our control from making the holiday home available and are unable to provide suitable alternative accommodation we will refund all monies paid by you but no further liability will be accepted.

2) Included in the rent are all linen (except for the cot), solid fuel for the open fires, oil for the central heating and electricity up to the value of £10 according to the units used on the meter. Telephones are charged at 10p per unit.

3) The number of people in the party is to be as stated on the booking form and in no case to be more than the stated maximum ie five people plus baby. Under no circumstances must the property be sub let. A reduction for a smaller group in **may** be made at the owner's discretion. Pets are welcome after discussion with the owner but there is a charge of £10 per dog and the property must be left as if there had been no pet there. Dog owners are asked to bring suitable beds and to keep dogs under control at all times.

4) The owner reserves the right to reasonable access to the cottage for inspection, repairs etc.

5) Any damage to crockery, utensils, furniture etc must be notified and paid for. Waterproof sheets are provided for all the beds. **If furniture is rearranged it must be restored to its original position before departure.**
